We are currently developing plans to submit a partnership bid to the Government's Youth Investment Fund Phase 2. This fund is primarily for the capital refurbishment/repurposing of spaces for young people. In the Forest of Dean the eligible wards are Lydney East, Coleford and Cinderford West.

Following initial conversations with other community partners, we have identified a potentially strong opportunity to develop and expand existing and new skate/bike parks in each of the eligible wards. Along with providing a welcoming and inspiring space for young people to come together, the aim would be to deliver sustainable projects and activities in these locations that support health and wellbeing, employability and life skills.

Phase 2 of the Youth Investment Fund (22/23 to 24/25) will deliver up to 300 facilities that represent positive value for money, are environmentally sustainable and enable positive activities for young people aged 11 to 18 (up to 25 for young people with Special Educational Needs and Disabilities) in eligible places across England.

YIF is a commitment to young people to transform and level up the out-of-school youth sector. It will provide truly innovative youth facilities in levelling up priority areas, and early-stage/seed resource funding to underpin them, enabling more positive activities that deliver improved outcomes for young people.

The Youth Investment Fund will drive value for money facilities that youth organisations can afford to sustain. Utilising innovative construction techniques, as well as supporting redevelopment projects that expand youth service provision, the YIF will achieve savings on facility running costs, benefiting operators so resources can focus on activities that enrich young people's lives.

Selected places and methodology

The Youth Investment Fund will level up areas where youth need is high and provision is low, creating a level playing field for young people to have equal access to youth services, trusted youth workers, and dedicated youth facilities that deliver positive outcomes.

Investment is targeted in areas of greatest need and enables local youth organisations in 45 local authorities and over 600 district wards in England to apply. Approximately one-third of all young people in England aged 11 to 18 live in these eligible areas.

The eligible areas have been identified and ranked by a combination of youth need and low provision. DCMS has developed a detailed methodology
(https://www.gov.uk/government/publications/youth-investment-fund-yif-places-selection-methodology) underpinning the selection of areas.

Eligibility

The lead applicant must be a local authority, a registered or exempt charity, a Community Interest Company (CIC) limited by guarantee, or a Community Benefit Society. This organisation will be accountable for managing the grant.

The funding can be used for new or renewed facilities that will deliver additional positive activities for young people aged 11-18 (up to 25 for young people with Special Educational Needs and Disabilities).

The planned building project will be in a selected eligible area. Check if you are in an eligible area using the Social Investment

All grant funds awarded by YIF must be spent by 31st March 2025.

In making funding decisions, Social Investment Business (SIB) will also look to consider:

- To what extent you have involved young people in the development of your project
- The strength of your project
- Your youth offer that it will expand access to youth services for local young people
- The resilience of your organisation that the lead applicant has the capacity to deliver your build project(s), and the ability to manage them well afterwards
- The viability of your project that it can be delivered within the lifetime of the fund (2022-25) and to budget
- How advanced plans for your project are. In project assessment rounds 1 and 2 particularly (to December 2022), SIB will be looking for projects at an advanced stage that could start work within three months
- The additional funding that you have already or will secure alongside the YIF grant

Thank you for your email, I will need to give my apologies for your meeting on 13 September.

There is no action required from CTC relating to the UKSPF shortlisted project at present. The District Council submitted their UKSPF Investment Plan to Government last month and is waiting for this document to be approved. No clarification questions have been raised to date and we anticipate that approval will be in Oct/Nov 2022.

Once the UKSPF funding allocation has been approved, the District Council will then be able to enter into formal agreements with all UKSPF project promoters. This is likely to involve some form of Grant Funding or Partnership Agreement. In the meantime, CTC is welcome to develop the project plan to support the *Coleford Community Regeneration Plan* work further. Although any input will be at risk at this stage, it would enable CTC to be well placed to commission technical survey or feasibility work in Nov/Dec 2022.

In terms of future face-to-face meetings – I can make 22 Sep am and 13/14 Oct. In September, an online meeting may be preferable?

Thank you for the Coleford Town Council expression of interest to the Forest of Dean District Council's UK Shared Prosperity Fund.

The Council has not run an open call for EOI's and yet still received £4.6m of projects against the £1m allocation being proposed by Government.

Scoring panels with elected member and officer input took place last week, one for each SPF investment theme. The Coleford Town Council EOI was considered under the Communities & Place investment theme. I am pleased to report that the Coleford Town Council EOI has been shortlisted for inclusion for Years 1, 2 and 3.

However, the funding requested by Year 1 & 2 shortlisted projects far exceed the £114,689 and £229,378 SPF funding amounts the Council expects to allocate in Year 1 & 2 respectively.

Accordingly, the Council's proposal is to offer Coleford Town Council a revised SPF funding contribution as follows:

Do you think Coleford Town Council would be interested in supporting this project for a sculpture that involves the community through artist workshops?

Many people have been through tough times since 2020 - we certainly have, and we hope that this would be a helpful way for people in Coalway and the Forest to celebrate happy life events and to remember those they have lost.

I attach a PDF which explains the project, its costs and the community element - with 5 site photos, an image of the proposed work, the plinth dimensions and an explanation of the beetles element. Please use the arrow in the bar at the top of the PDF on the left hand side, rather than the scroll bar, to be sure to see each page.

With local friends we have settled on a couple of Coalway sites as shown, each having their pros and cons that will need to be debated. Below ground issues, including the roots of the Oak in the centre of Coalway, may end up being the deciding factor.

Whilst understanding that it takes time for the council to go through the democratic processes we would be grateful if the council could let us know if they wish to support this project, or not, as soon as it is feasible.


This could be a route to having another gateway sculpture at a low cost of £4,000 excluding VAT, the below ground base, and the Council's time spent on planning permission etc.



The last three years have been very difficult for many, we decided to apply to Coleford Town Council to see if it would be possible to create this celebratory community Gateway Sculpture to help lift people's spirit.






Photo by Lin Holland, the sculpture shown was photoshopped in all photos by Diane.

The Sculpture aims to celebrate the Forest and people. This, and the above photo by Michele Covington Jones, shows the turn off to Parkend Walk, at the entrance to Coalway on Parkend Road, for site 1.

PJ Engineering will donate the small stainless steel stag which was made to work out how to make the full scale 'Spirit of the Forest'.

Diane and Phil will donate their time for the project.

Damon Bramley Sculpture Transport and Installation will transport and install at cost.

A neighbour will donate £2,000 for the project which we hope Coleford Town Council could match fund.

If the Council could use their funds to pay for the elements that charge VAT, the money would go further as the council did for 'Spirit of the Forest'. Dean Oak suggested that we approach the Forestry Commission to see if they could donate can claim the VAT back. We also hope that Complete Utilities might consider donating the below ground base, as they the Oak which would help reduce their fee.



Why Beetles?

They can be jewel like and colourful, a sturdy shape, so easy for most people to make. However we need to create beetles without vulnerable legs and antennae, as these would be likely to cause problems when fixing them to the plinth from scaffolding. We want jewel like beetles similar to the scarabs Egyptians created, and there are lots of different beetle shapes and colours to be inspired by. Make a beetle that has some personal element, such as a colour or pattern that reminds you of a new baby in your life, a partner or someone who has died.

"Beetles are not only everywhere, in every shape, size and form, they can also be found all year round. They indicate freshwater quality, ecological continuity of threatened habitats like ancient woodlands and chalk downland; they are an excellent measure of local conservation effort and regional biodiversity. It is a beetle (the harlequin ladybird,) which offers the best model and most studied example of a newly colonising species spreading across the British Isles, since it arrived in Essex in 2003. Beetles are already at the forefront of climate change research as Mediterranean species invade and cold-adapted northern and mountain-dwelling species are edged further north, or further up mountainsides.

If an alien civilisation arrived on Earth and, with limited time and limited resources, wanted to understand how life here operates, all it need do is to study beetles and dismiss everything else as sampling error. Beetles are, without any doubt, the most important organisms on the planet."
