# 155. To agree to the response to the NHS Consultation re Forest of Dean Community Hospitals



Cllr Penny summarised the position, also reporting two subsequent meetings with the Clinical Commissioning Group and, after discussion it was agreed that a Council response should capture Neighbourhood Development Plan 's comments, as well as Student's views (following Council engagement with Five Acres students) and that in summary, the Council to support single hospital option, the need to consider transport links to any new site, account to be taken of demographics and population increase in respect of bed availability, and also full consideration to be given to any disposable assets.

# 156. To agree a response to the planning application P0626/16/FUL land at Tufthorn Avenue Coleford Glos. The erection of Class1 limited assortment discount food store with associated car parking, landscaping and ancillary works

### 157. To agree to the next steps re District Council Lawnstone House development

Cllr Penny asked Cllr Baird to lead discussion as Neighbourhood Development Plan had actively engaged with District Council on this development proposal. In summarising, Cllr Baird reported that the Neighbourhood Development Plan had met with District Council and put forward some reasonable suggestions, however all had been dismissed by the District Council. The Neighbourhood Development Plan were, in turn, planning some campaigning activity through press releases; and sought Council support on this. Following further discussion, Cllr Penny summarised Council views of disappointment, particularly in light of District Council press releases stating that they were working in partnership with the Town Council and Neighbourhood Development Plan that the community views has been totally disregarded. It was proposed that a press release be issued stating the Town Councils disappointment and that the Council fully supports the Neighbourhood Development Plan.
