**Item 5:** Cllr. M Cox summarised the response from Andrew Phillips, CCG, Glos, and it was agreed that this would be considered further once the planning application has been submitted re: new Health Centre

**6. To take comments from the public forum**

Mr Williams stated that he was keen to hear an update re: Lidl and, in respect of the proposed new health centre, felt that it would be too late, once it had got to planning stage, and his comments were noted.

**7. To update on Lidl access**

Cllr. M Cox summarised, and it was reported that there had been no further clarification from Lidl, in response to further attempts to clarify, by letter with them. The Assistant Clerk reported on a telephone exchange he had had, in respect of the last letter sent, and had been disappointed with what he believed to be a disappointingly dismissive tone, with the Lidl representative, in respect of that clarification. Cllr. Penny also reported that he had had contact, with his contact at Lidl, who was investigating further and would speak to her again, in an attempt to progress outstanding matters. Cllr. M Cox further updated on recent works undertaken, by Lidl, having visited the site. It was noted that further improvements to the Old Station Way disability access were now in place, but no difference to the rear access. The sign for access to the Town Centre via Pyart Court was still not in evidence. The Building Inspectorate had still not forwarded completion certificates to FoDDC. After further discussion, it was agreed to wait to see what Cllr. Penny might be able to achieve, through his contact at Lidl, and then for the Town Council to consider writing again to Lidl, to include raising the manner of the telephone exchange from the Lidl employee to the Assistant Clerk, which Council felt was not acceptable.

**8. To note recent planning decisions**

Cllr. M Cox summarised decisions listed, and raised concerns re: Planning application P2104/20/FUL (40 Sparrow Hill) in that Welsh Water had not been consulted despite the clear statement that '*Severn Trent is not admissible for sewerage. This should be requested from Welsh Water, the relevant authority*' within the comment sent by this town council planning committee, re: this application. The officer report was incorrect, and should have explored the local knowledge provided by the Council as is our role. Cllr. Elsmore particularly, also raised concerns in respect of this matter. After further discussion, it was agreed that the Town Council should formally write to FoDDC, Planning with regard to officers not giving due attention to CTC comments.
